



## TESSA JOB DESCRIPTION

<b>JOB TITLE:</b>	Children's Clinician
<b>REPORT TO:</b>	Clinical Director
<b>TIME REQUIREMENT:</b>	Full Time (40 Hours/Week)

**SYNOPSIS:** Therapist provides therapeutic assistance to residential and non-residential children who are clients of TESSA with a primary focus on the issues of domestic violence, sexual assault, and human trafficking. In addition to working with children served at TESSA's offices, this position will provide services to students and work closely with educators in the Harrison SD2 as part of the Transforming Safety guidelines and requirements. The position also includes building relationships with partners and providing parenting classes and other training.

### RESPONSIBILITIES:

#### Client Services

- Provides assessment and therapeutic services for child victims of domestic violence, sexual assault and human trafficking through individual and psycho-educational and therapeutic groups per client need and grant requirements.
- Provides therapy and support to parents of children of domestic violence and sexual assault to aid in the healing of child.
- Designs a parenting class curriculum utilizing TESSA materials.
- Provides time-limited, goal-directed therapy to enable service provision to a high-volume of clients. Refers clients with additional needs to appropriate services.
- Provides on-site therapeutic services to students in Harrison SD2.
- Provides clinical/educational groups a week over variety of topics (Healthy relationships, boundaries, parenting, seeking safety, social media influence etc.) with a specific focus on Harrison SD2.
- Works with the Youth and Children's Program staff to develop and implement treatment and service plans for children and parents.
- Follows ethical guidelines of the ACA, APA, and AAMFT including keeping all client information confidential as directed by the client.
- As needed, will provide case conceptualizations/assessment presentations of youth/family clients for Safehouse staff during weekly meetings.
- Attends weekly/biweekly/monthly clinical supervision with Clinical Director.
- Facilitates weekly consultation for interns/staff that are working with children and families.
- Works cooperatively with other agencies and individuals involved with the client to assure comprehensive service delivery.
- Develops knowledge and expertise regarding domestic violence, sexual assault and human trafficking.
- Provides education and information to the client to support informed choices.



- Treats clients with respect, dignity, and empathy.

#### Record Keeping

- Completes necessary documentation of services for each client contact within by end of work week.
- Maintains client records in a timely and accurate manner.
- Assists in collecting client statistics for program evaluation/management and grant reporting.

#### Cultural Inclusivity

- Delivers programs and services in a manner that is respectful and sensitive to the clients' cultural experience.
- Develops multicultural services, programming, and outreach as appropriate.
- Prevents, identifies, and removes discriminatory barriers in services provided.
- Recognizes that we hold attitudes and beliefs that can detrimentally influence our perceptions of, and interactions with, individuals who are diverse from ourselves.
- Applies the principles of multiculturalism and diversity in training and staff development.
- Applies culturally appropriate skills in all interactions with clients, co-workers, volunteers, partner agencies, and other community members.
- Uses organizational change processes to support culturally informed organizational policies and procedures.

#### Other

- Understands department objectives and how they relate to the goals of the agency.
- Attends staff, other relevant meetings, trainings, and in-services as assigned.
- Commits to TESSA's organization mission, vision, and operating philosophy.
- Assist in the training/monitoring of clinical interns for TESSA.

#### **QUALIFICATIONS AND REQUIREMENTS:**

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. - Master's degree in a Behavioral Science (Community Counseling, Psychology, Family Therapy, etc.)
- Colorado licensure preferred (LPC, LMFT, LCSW, etc.).
- Experience/training in play therapy required, Certification in Play Therapy preferred
- EMDR Level I and II certification preferred.
- Two years relevant work experience including: with child victims, systems professionals (law enforcement, District Attorneys, etc.).
- Displays a positive attitude, works well with others, and accepts direction well.
- Excellent organizational, communication, problem solving, listening and interpersonal skills/
- Able to maintain attention to detail while working toward big picture objectives.
- Able to work evening and on-call shifts.



- Able to work well in stressful and emotionally taxing circumstances and engage in effective self-care.
- Able to independently use a computer for word documents, spreadsheets, presentations, email, internet research, data entry and data management.
- Possess vision and hearing sufficient to work on a computer, on the telephone and in person.
- Able to lift 50lbs, intermittently.
- Valid driver's license and car insurance
- Must be willing to complete background checks.
- Able to read, write and speak English.
- Multilingual (Spanish, ALS, etc.) a plus.
